Introduction:

Lori D'Andrea welcomed and thanked everyone for attending the meeting.

Proposed Teacher Center Grant

The Teacher Center Director advised the Policy Board members that we received a cut in funding this year (approximately 1/3 from last year). However, we can still provide a robust offering of professional learning opportunities with the money we have been awarded from the state plus the financial support we receive from our consortium districts and unions.

Proposed Budget

The Continuation Application was discussed and a copy of the work matrix and budget were provided for the members to review and approve. After all questions were addressed, a motion was made to accept the proposed 2024-25 application and the corresponding budget.

At the conclusion of the presentation, a motion was made by Michelle Yang-Kaczmarek to approve the Continuation Application Grant along with the proposed budget as outlined. The motion was seconded by Sheila Ahern. All members were in favor – no opposed and no abstentions.

Summer Grant Course Offerings

The free summer classes being offered through the grant were discussed. Board members were asked to share these course offerings with their colleagues. The Teacher Center will hold an equitable amount of seats for each of our consortium districts.

Educational Leadership Program

Lori told the PB members that the Teacher Center and their co-sponsor, Hunter College, will begin their fifth cohort in the fall of 2024. A number of previous graduates have already advanced into administrative positions.
